This document is intended for on-site technicians and remote maintenance center personnel supporting a Lucent INTUITY switch conversion.

Press 1 to record a message.



Conversion Instructions

Overview

This section describes how to convert INTUITY Messaging Solutions Release 5 systems to one of the following switches:

- DEFINITY® CLAN
- DEFINITY® DCIU
- MERLIN LEGEND® or MERLIN® MAGIXTM Mode Code
- DEFINITY® PROLOGIXTM or DEFINITY® BCS Mode Code



CAUTION:

Follow the steps in these instructions in the exact order in which they appear. Failure to follow the instructions in this document in the exact order will result in conversion failure.

For technical assistance with Lucent INTUITYTM systems integrated with MERLIN LEGEND® Communications System or a System 25, call the NSAC at 1-800-552-3293. For all other integration types, call 1-800-248-1234.

Task 1: Stop Alarm Origination

This procedure inactivates alarm origination so that the Lucent INTUITY system does not inform the remote support center of any alarms that occur during the update process.

Note:

If the system does not have alarm origination and is not integrated with a DEFINITY® communications system, continue with Task 3, "Stop the Voice System," on page 2-7. If the system is integrated with a DEFINITY system, continue with Task 2, "Busyout the Link: Lucent DEFINITY Switch Integration Only," on page 2-4.

To inactivate alarm origination:

- 1. Login as craft
- 2. Press (ENTER) to accept the AT386 default.

The system displays the Lucent INTUITY Main Menu (Figure 2-1).



Task 2: Busyout the Link: Lucent DEFINITY Switch Integration Only

For System 75, G1, G3, and R5/6/7/8 Switches with DCIU Integration

To busyout the link, go to the DEFINITY switch monitor, and perform the following steps:

1. Enter **busy link** *n*

Where n is the number of the physical link to the Lucent INTUITY system. n may be any integer from 1 to 8.








The following procedure describes how to stop the Lucent INTUITY voice system so that you can backup the system and install the new software.

1. Start at the Lucent INTUITY Main Menu (Figure 2-1) and select:



The system displays the System Control screen (Figure 2-5).

2. Select Stop Voice System.

The system displays the Wait Time window (Figure 2-6).

3. Type **60** in the Wait Time window and press **F3** to save the wait time.

The system responds by waiting 60 seconds and then stops the voice system. This process could take several minutes. The system then returns to the System Control screen or displays the following message:

```
The Voice System has stopped. Press ENTER to continue.
```









Figure 2-10. Back View of the MAP/5P and MAP/5PV3






Figure 2-13. LAN Circuit Card




Figure 2-14. MAP/5P and MAP/5PV3 Internal Layout








Figure 2-17. LAN Circuit Card








Figure 2-20. LAN Circuit Card

Figure 2-24. Cabling Arrangement Using Crossover Cable





Figure 2-25. Cabling Arrangement Using Hub or Router



Figure 2-27. System 75, G1, G3i, G3s, and G3vs IDI Connection to the Switch






Figure 2-28. DEFINITY G3r IDI Connection to the Switch





Figure 2-29. Network Interface Card Set-up













Figure 2-42. Voice Board Diagnostics Menu







- 12. While the local machine is busied out, determine your next step:
 - If the INTUITY has been upgraded to a Release 5 system and you need to connect to each remote machine with which the local machine is networked, contact AUDIX Enhanced Services at 1-800-776-2323.
 - If the INTUITY has not been upgraded and no network work is needed, continue with step 13.



CAUTION:

The network ports of the machine on which the local subscriber's extension length has been changed **must** remain busied out until the change has been administered on all remote systems.

- 13. Determine your next step:
 - If you need to change a block of extension numbers without changing the extension length, continue with "Changing a Block of Extensions (without Extension Length Change).
 - If you are finished changing extensions, continue with "Release the Voice Ports," page 2-92.

Changing a Block of Extensions (without Extension Length Change)

Change a block of extensions from one series of numbers to another as follows:

- 1. Read the precautions that are given starting on page 2-83.
- 2. For each system (remote or local) that needs to have a new range defined to accommodate the intended new block of extensions do the following.

Access the AUDIX **change machine** *name* screen and define an address range that includes the new block of extensions.

Note:

Be sure to perform this step first. If all machines are prepared for the change, service across the network will be little affected.



(In the example, the 100 extensions to be moved are those currently numbered between 29900 and 29999.)

Here you enter the *beginning number of the new block of numbers* to which the extensions named in the preceding step are to be moved. (In the example, extension number 29900 is to be changed to 29600, and numbers up through 29999 are to be changed to corresponding numbers above 29600. For example, an extension 29947 becomes extension 29647.)

All other fields are display fields.

8. Press [3] (Enter) to initiate the process.

If the system fills in the Ending With field and asks you to confirm your intent, continue with step 9.

If the system fills in the Ending With field and prints "Subscriber Already Exists," you have specified a range of numbers that includes at least one number that is already assigned. The system will not permit the Change Extensions screen to delete an existing number in the course of adding another. In this case, continue through the lettered steps below:

- a. Access (F6) (Cancel) to exit this screen.
- b. Type **list address ranges** at the command line. Discover from the resulting list where to find extensions within the range you earlier specified to receive the extensions being changed.
- c. Having determined in the previous step which machine(s) have the problem extensions assigned, either type list extension if the machine is local, or type list remote-extension < remote machine name > if the machine is remote.
- d. Use this information as a basis to reconsider the target range of numbers. Once you have worked out new number ranges, return to step 1 of this procedure to implement them.
- 9. Press F3 (Enter) again.

The system fills in the display fields as it works and displays the message Command Successfully Completed when finished. The cursor returns to the command line.:

Note:

If for some reason you have to press $\[\]$ (Cancel) during this operation, a certain amount of work will already have been done by the program. Recover as follows:

- a. Note the numbers shown in the display fields. They will indicate approximately where the program stopped working.
- b. Next, list extensions to find exactly which numbers have been changed and which have not. (Use the **print list e** command to make a copy on your system printer.)

c. Finally, plan what needs to be done to recover, and use the **ch e** command to change extension numbers as necessary.









Figure 2-57. Alarm Log Display Screen








