

VP-2048B 48 VOLT DC POWER SUPPLY

IDENTIFICATION

The VP-2048B is a fully regulated 48 Vdc 2 amp power supply ("A" Battery). The input and output are fuse protected and the output is floating with respect to ground. The regulator will maintain 48 ± 3 volts over the entire input voltage range. Upon power up, a load greater than 2 amps will shut the power supply off and cause the overload LED to illuminate. Short circuit protection is also provided. The VP-2048B can be used with Valcom V-1038 paging horns or any application where 48 Vdc filtered ("A") battery is required. The VP-2048B is CSA Approved.

INSTALLATION

The VP-2048B is designed to be wall-mounted within 4.5 feet of an AC receptacle.

1.	Using 12 AWG or larger ground wire, connect the local ground screw terminal to a cold water pipe or earth ground.
2.	Connect device requiring power to screw terminal labeled -48V, 2A and to the screw terminal labeled GND.
3.	Connect a strap between the local ground and ground output terminals when using the

VP-2048B with Valcom equipment.



This warranty is in lieu of and excludes all other warranties, expressed or implied, and in no event shall Valcom, Inc. be liable for any anticipated profits, consequential damages, loss of time or other losses incurred by the buyer in connection with the purchase, operation, or use of the product.

This warranty specifically excludes damage incurred in shipment. In the event a product is received in damaged condition, the carrier should be notified immediately. Claims for such damage should be filed with the carrier involved in accordance with the F.O.B. point.
